same screening, evaluation, and selection procedures and shall be subject to the same eligibility requirements prescribed in Division Memorandum No. 243, s. 2026.

June 16, 2026	Deliberation of Qualified Student-Athletes Scholars	BBB Conference Hall, Schools Division Office of Bataan, Abucay, Bataan

5. Only applicants who have successfully passed the Paper Evaluation, Written Examination, and Interview shall proceed to the Sports Aptitude Test and Physical Fitness Test.
6. The Sports Aptitude Test and Physical Fitness Test shall be conducted for applicants in the following sports disciplines:
- Athletics
  - Gymnastics
  - Swimming
  - Taekwondo
7. Priority consideration for admission and scholarship grants shall be accorded to qualified student-athletes who have officially represented the Division of Bataan in the Central Luzon Regional Athletic Association (CLRAA) Meet and/or the Palarong Pambansa, in recognition of their demonstrated athletic excellence, competitive achievement, and potential for high-performance sports development.
