**ASSISTANCE IN THE VERIFICATION AND CHECKING OF APPOINTMENTS
 FOR TEACHERS PROMOTED UNDER THE EXPANDED CAREER PROGRESSION (ECP)**

This Office informs all concerned Administrative Officers II listed hereunder that their assistance is required for the verification and checking of appointments of teachers who were promoted under the Expanded Career Progression (ECP). Likewise, all concerned personnel are advised to observe the provisions of CSC-DBM Joint Circular No. 1, s 2015, titled Policies and Guidelines on Overtime Services and Overtime Pay for Government Employees.

Alternatively, non-teaching personnel shall be granted Compensatory Time Off (CTO) for services rendered during weekends and holidays, subject to the provisions of CSC-DBM Joint Circular No. 2, s. 2004, DepEd Order No. 30, s. 2016, as amended by DepEd Order No. 005, s. 2019, and other existing rules and regulations.
