This is pursuant to Republic Act No. 7278 (BSP Charter) and the official BSP Senior Scouting Advancement Scheme to ensure fairness, character development, and leadership excellence.

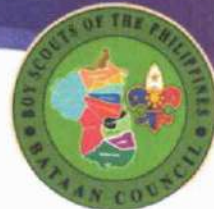

3. Pre-Board of Screening (Document Audit)

- **Requirements:** Folders must contain proof of active registration, complete merit badge certificates (22 for Venturer, 27 for Eagle Scout), character references, parent consent, and the Eagle Scout Project Report (for Eagle candidates only).
- **Deficiencies:** Candidates with incomplete documents will receive a deficiency notice and must comply before re-scheduling.

4. Board of Review Proper

Attire: Candidates must wear the complete **BSP Type A Uniform with sash.**

Focus: The panel evaluates the candidate's character, community project impact, personal growth, and daily practice of the Scout Oath and Law.

5. Administrative Rules

Impartiality: Scout leaders and relatives are strictly barred from sitting on the review panel of their own Scouts.

National Endorsement: Successful Venturer Scout will be officially endorsed to the BSP Regional Office for final approval and Eagle Scout candidates will be officially endorsed to the BSP National Office for final approval.

Re-interview: Unsuccessful candidates will receive constructive feedback and may re-apply after 30 days.

6. Conduct of Board of Review and Court of Honor based on rank.
